STUD FEE & FEES

- 1) **BOOKING FEE \$ 000 _____, this is NON REFUNDABLE UNDER ANY CIRCUMSTANCE.**
- 2) **STUD FEE \$ _____ the booking fee is credited towards stud fee. The stud fee is nonrefundable & nontransferable to another owner unless Crestwood Acres is contacted before it is transferred.**
- 3) **The mare owner is responsible for all collection and shipping fees. Mare owner must contact Stephanie Richardson, 615-202-4702 or Hollis Kelley, 615-849-5465, to arrange payment before stallion is collected, all collection and shipping fees must be paid before semen is shipped. We accept bank/cashier's checks and PayPal.**

PRIOR TO SHIPMENT:

- 1) **NOTIFY Hollis or Stephanie when the mare foals or when she first comes into heat, this is a "heads up" for us that you will be in need of semen soon.**
- 2) **Expected breeding date is _____**
- 3) **A signed contract & ALL FEES MUST BE PAID IN FULL along with all paperwork must be submitted prior to shipment.**

GUARANTEES:

- 1) **In the case of dead or poor quality semen, a veterinarian must contact the stallion owner with a report before a new shipment will be sent. The stallion owner saves samples for examination and comparison of what is shipped.**
- 2) **In the case the stallion dies or becomes sterile, Crestwood Acres will offer another stallion or refund the stud fee minus any booking fee that has been prepaid.**
- 3) **In the case the mare is unable to conceive or dies, the mare owner has the option to use a**

replacement mare (Mare owner will be responsible for any additional collection and shipping fees). The mare owner agrees that he/she will have the contracted mare pregnancy checked within 45 days of the last breeding date or this contract is **NULL AND VOID** with no further obligation of the stallion owner to provide semen or honor any portion of this contract . _

4) A **LIVE FOAL GUARANTEE** is one that stands, nurses and lives for 48 hours after birth.

LEGAL AGREEMENT:

- 1) In the case of **ANY DISPUTES** or breach of contract, Tennessee law will preside as this is a Tennessee sale. Therefore it is agreed that any legal action will take place in a Rutherford County, TN court of law.
- 2) It is also agreed that in the case of any litigation, if the judgment is in favor of the stallion owner, all of the stallion owner's legal fees will be paid by the mare owner.
- 3) By signing this contract I, the mare owner, agree to all terms thus making this a binding contract. It is the mare owner's responsibility to **MAKE A COPY** of this contract for their own records.
